June Colby, Susan Scanlon, George Smith, Sr., Corrine Witham, Alice Mears, Mr. and Mrs. Eugene Smith, Charlotte Line, and Kris McCrory.

The meeting opened at 2:25 P.M. with a prayer by June Colby. The president suggested a round of introductions so all present would know each other.

#### Report of the Annual Meeting Sept. 15, 1985

The ladies were presented carnations, courtesy of Ralph McGray, and, after the taking of dues by the treasurer, and the distribution of reserved dinner tickets by Rebecca Rupright, we sat down to a family style turkey dinner at 1:15. Grace was given by our chaplain, June Colby.

Our business meeting opened at 2:50 P.M. with a reading by our Chaplain of Chapter 8 of Romans starting with the 16th verse. After a Salute to the Flag and a general round of introductions, the Secretary's Report of both the Special and Annual Board of Directors Meetings were read and accepted. The Treasurer reported \$392.75 in the general Fund and \$217.74 in the Judith A. Smith Fund. She also reported a balance in the Beatrice Smith Hunt Memorial Fund of \$173.64.

At the reading of the list of Our Dear Departed, Ethan Brown place the flowers in the wreath. Acting upon a motion made by Carol Ann Ferris and seconded by Charles Abraham, it was voted to place the wreath on the grave of Earl Colby.

Mertie Cunningham, aged 94, had to leave after dinner; the oldest lady then present, at 90 years, was Charlotte Broughton, who received the corsage for this honor. Ralph McGray, at 95 years young, received the boutonniere for being the oldest gentleman present. Beth Ferris and Caleb Brown tied for the title of the youngest attending, at 10 years of age. Ralph lost the title for having come the furthest to Charles Smith from Anchorage, Alaska.

At this time a collection was taken up for the general fund to which we added \$131.05. Also, all were given a change to sign a card for Barbara Wickens who was too ill to be with us.

Carol Ann reported that she had had a good response to the letters she had sent out requesting information on lineage, but had a very poor response to her request for the same from members who had been at the Annual Meeting in 1984. She repeated her request for vital statistics. She also announced that she would be happy to obtain badges for any who wanted them.

Under new business, the revised By-Laws were read. Upon motion by Charles Abraham, and with 3 or 4 second motions, they were approved unanimously. A motion was made by Alice Mears and seconded by Romaine Abraham to have the Revised By-Laws printed in whatever form was approved by the Board of Directors. This was also approved unanimously.

June Colby resigned as Editor of the Report; Bonnie Cummings volunteered to fill the position, and was so appointed.

Carol Ann announced she had some Association Papers with her. She read "A Poem to Any Man who can Trace His Wife's Lineage to Adam" and an excerpt from the "Autobiography of Arthur Nehimah McGray" who was the father of our own Ralph McGray. She also had Ralph McGray's Lineage, as well as the story of the founding of the Church in Barrington, Nova Scotia.

Charles Smith, of Alaska, spoke about the five generation project. He had made up charts for 5 generations showing 7 individuals in the 2nd generation. Using a progression of 5, he showed 35 persons in the third generation, a possible 150 in the fourth generation, (of which he has 78 documented,) and a possible 750 in the fifth generation, (of which he has 163 documented).

Charles recommended reading sections of the New England Historical & Genealogi-cal Records. He also spoke of The Family of Ralph Smith of Hingham by Thomas Smith of Boston, which lists other articles dealing with Ralph Smith and his family.

It was proposed that our next annual meeting be held on the Cape. After much discussion it was decided to leave the decision up to the Board of Directors, who are to have a Special Meeting. They are to discuss the possibility of a special way of celebrating our 50th Anniversary, such as an extra meeting, slides, etc.

George Smith, Sr. made a motion, which was seconded by several and approved by all, to hold our next Annual Meeting at the Nahant Country Club.

June Colby suggested that as our benediction we all join hands and sing "Blest Be The Tie That Binds". A collection for the Judith Smith Fund realized \$40.52. The meeting closed with a collation of cookies and punch and much conversation.

## THE SETTLING OF HINGHAM (MASSACHUSETTS)

Ralph Smith, when only 23 years of age, left his native Hingham, in England, and sailed in company with 95 others of the "Elizabeth Bonaventure": bound for the New World. The small ship departed from Yarmouth on the first week in May, 1633, under command of Capt. John Graves, and arrived at Boston Harbor on the 15th of June, just 313 years ago. [Ed. note: Originally Mr. McGray wrote 313 years; they landed in 1633.3 They immediately organized several small squads of men into exploring units, to locate a suitable place for a new settlement. Meantime, it is assumed. that their ship, lying at anchor off Charlestown. continued to afford shelter for its passengers. After a period of intense search. it was decided that Bare Cove. (now Hingham), best met their requirements. Consent of such officials as then held sway at Boston was obtained for starting a settlement there, and it is recorded that in September of that year: "the following men went there and began building huts and clearing land for planting the following spring, vis: RALPH SMITH, Nicholas Jacobs. Thomas Lincoln, Edmund Hobart, Jr., and Thomas Hobart." Many of their friends who had wintered at Charlestown joined the little group in the spring of 1634. From then on the small settlement was steadily supplemented by new arrivals, many of them coming from Hingham, England and in June, 1635, their old Pastor there, Rev. Peter Hobart, with 139 of his congregation came and added their presence to the two-year old colony; the Hingham-To-Be of New England.

# BRIEF HISTORY OF HINGHAM, MASSACHUSETIS

Hingham, a post town containing 13,775 square acres in the County of Plymouth, Mass., has the bay to the north, Cohasset to the east, Scituate and Abington to the south and Weymouth to the west. The greatest extent of the town from north to south is seven and three quarter miles and from east to west about five miles. The distance from Hingham to Plymouth is 26 miles, and from Hingham to Boston about 14 miles by land and between 12 and 13 by water.

The original limits of Hingham embraced the present town of Cohasset, which was set off and incorporated April 26, 1770. Hingham formed a part of Suffolk County until March 26, 1793, at which time it was annexed to the new County of Norfolk. However, this act, so far as it related to Hingham and Hull, was repealed by an act of the Legislature on June 20, 1793, and Hingham again became a part of Suffolk County. By an act passed June 18, 1803, Hingham was annexed to the County of Plymouth, of which it still forms a part.

## HINGHAM MEMORIAL

On the 275th anniversary of the founding of the New Hingham, a memorial tower was erected in memory of the first settlers by public subscription and through the efforts of Rev. Louis C. Cornish. It is situated adjacent to the Old Ship Church, at the entrance of the old burying ground where many of the fore-fathers are buried. In the belfry of this tower are seven bells made in London; copies of the bells in churches at Hingham, Norwich and several other adjacent towns in the county of Norfolk, England. Inscribed on the lower part of the tower is the following:

This memorial is erected by public subscription on the 275th anniversary of the settlement commemorates the men and women who for the sake of liberty and at great sacrifice came out from Hingham, England and towns adjacent between the years 1633 and 1638 and on the edge of the wilderness established this free plantation of New Hingham.

1633 Ralph Smith, Nicholas Jacob, Thomas Lincoln, Edmund Hobart, Theophilus Cushing, Edmund Hobart Sr., Joshua Hobart, Henry Gibbs, etc..etc

Located in this tower is one of the most interesting relics in New Hingham. The Hing-ham Stone was sent by Old Hingham to it's namesake here as an anniversary gift; it was supposed to be the only stone that could be found in Hingham. England.

The Hingham Stone, long used as a mounting block, is believed to have stood for centuries on the Village Green and to have been known to the Forefathers before the migration. The Hingham Stone was given by the town of Hingham, Norfolk to the town of Hingham, Massachusetts for their Memorial. It was presented on October 9, 1911, by the Right Hon. James Bryce, D.L.C., Ambassador for Great Britain to the United States.
